Tēnā koe

I refer to your email to the Ministry for the Environment dated 25 November 2024, requesting the following under the Official Information Act 1982 (the Act):

"I request under the Official Information Act any communications from the Ministry, or prepared by the Ministry, to iwi/hapū in relation to the extension of port coastal permits or proposed changes to the regime around port coastal permits. I also request any communications received back from iwi or hapū in relation to any such communications from or prepared by the Ministry."

This request has been partially transferred to the Ministry of Transport.

25 documents fall within the scope of your request and are detailed in the document schedule attached as Annex 1. The schedule outlines how the documents you requested have been treated under the Act.

Certain information is withheld under the following sections of the Act:

- 9(2)(a) to protect the privacy of natural persons
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty

With regard to the information that has been withheld under section 9 of the Act, I am satisfied that the reasons for withholding the information at this time are not outweighed by public interest considerations that would make it desirable to make the information available.

You have the right to seek an investigation and review of this response by the Ombudsman, in accordance with section 28(3) of the Act. The relevant details can be found on the Ombudsman's website <u>www.ombudsman.parliament.nz</u>

# Extending existing port coastal permits under RMA

# Context

- The introduction of the Resource Management Act 1991 (RMA) required ports to obtain permits to continue some of their operations in the coastal marine area in the interim while they transitioned into the RMA planning framework. These permits were only for coastal occupation activities they were carrying out at the time and are set to expire in September 2026.
- The permits cover crucial aspects of port activities like navigation aids such as buoys, lights and fog signals, exclusive occupation areas such as safe anchor areas, and some structures such as wharves.
- Since 1991 when the RMA was introduced, ports have expanded and new activities in the coastal marine area have been permitted under the RMA. However, the complexity of the RMA has made gaining consents for pre-1991 activities increasingly difficult.

# Proposal

# The Government proposes to extend the coastal permits granted to port companies under section 384A of the RMA for an additional 20 years.

The proposal:

- The Government will extend these permits as part of a number of targeted changes to the RMA to be passed in 2025
- This extension will be automatic and not require an application
- The expiry date of each consent will change, and there will also be a new process to introduce or modify consent conditions on these permits.

Impacts of the proposal:

- Port companies will have an additional 20 years to transition to permanent resource management arrangements
- The extension will provide ports with the certainty they need to invest and operate in the coastal marine area for the time being
- A process will be established to introduce or modify consent conditions on these permits where necessary.

Kia ora korua

Thanks for taking the time to meet with me this afternoon. I really appreciated it.

In terms of action points, I note Rebecca that you will send to me PDFs of:

- 1. The points where the navigational aids (buoys/beacons and lights) are that guide ships into and out of the port; and
- 2. The area which is designated for safe habouring for ships from unsafe weather which extends to the harbour master then being able to guide them into the port area if able.

In terms of the first issue, I would also like to see the structures and how those structures are locked into the seabed. As I said, I walk the Waikanae beach and see both the navigational aids and the area where ships harbour – on top of the cruise ships that just park out in the bay.

With regard to the permits, I note:

- 1. In 1992-1995 I led Te Runanga o Turanganui a Kiwa which at that point in time represented Ngai Tamanuhiri, Rongowhakaata and Te Aitanga a Mahaki;
- 2. During that time we opposed:
  - a. The dredging and discharge by dredgings of Port Gisborne;
  - b. The pipeline of the Gisborne District Council; and
  - c. The discharge of the Gisborne District Council through their pipeline on the seabed.

This background does not relate specifically to these permits because, as you noted, these permits were done by the Minister of Transport and I don't recall being consulted on those at the time. But I stand to be corrected.

Having said that, the issues outlined by my people from 1992 to 1996 are still relevant to all activities on the seabed and within the moana.

My people who gave evidence on both resource consent applications 30 years ago included Rapiata Ria (Senior), Nona Haronga, Kingi Smiler, Peter Gordon, Vivienne Pohatu and Nuna Wyllie. I met with them all and recorded their evidence, and was there when the evidence was presented in the independent commissioner led committee and the Planning Tribunal before Judge Turner.

Relying on memory from 30 plus years ago.

Nuna Wyllie is the only person still alive of those who gave evidence. Along with Vivienne Pohatu he outlined, on behalf of Ngai Tamanuhiri, the tide movements and all the fishing grounds that would be affected by the discharge of dredgings back into the moana. He had a map that was produced.

There were a number of agreements reached on each application by agreement (with the Port) or through the Planning Tribunal/Environment Court.

Separate hapu and lwi have taken their own action subsequently with the Port and/or Gisborne District Council or its LATEs in this area (including tributaries that affected by the Port) based on where the activities took place and the impacts on the catchment, moana and the life in the catchment and moana. These include:

- 1. Ngati Oneone & Te Runanganui o Ngati Porou
- 2. Rongowhakaata
- 3. Ngai Tamanuhiri
- 4. Te Aitanga a Mahaki
- 5. Te Runanga o Turanganui a Kiwa

I have copied in the key people of each of these groups and have included my Chair Pehimana Brown for Te Aitanga a Mahaki instead of Dr Ian Ruru who led a lot of the activities at the time. So the people copied in are:

Subject to and without impacting on the decision of any other hapu or lwi, the position of Te Aitanga a Mahaki is:

- 1. These permits are necessary to ensure safe entry in and out of the port, and safe habouring during inclement weather;
- 2. Tangata Whenua needs to be involved in the shape of how the permits are implemented to ensure the impacts are understood and where possible mitigated including:
  - a. Impacts on the mauri of the moana;
  - b. Impacts on the physicial seabed;
  - c. Impacts on the kaimoana including taunga ika (fishing grounds) of tangata whenua.
- 3. Tangata Whenua must be involved in the design and implementation of the navigation aids and harbouring sites and ongoing monitoring.
- 4. The best vehicle for Te Aitanga a Mahaki to achieve this is through the Local Leadership Board (details attached) as an impact on the moana affects multiple whanau, hapu and Iwi.
  - a. Te Aitanga a Mahaki would ensure, over and above any separate agreements that they reach, Ngati Oneone is a part of the design and implementation in the Local Leadership Board through Te Aitanga a Mahaki.

I will touch base with the other Iwi CEs and look to make a formal submission on this issue but would appreciate seeing and inputting to the final advice that goes from MOT and MFE based on this feedback. 

I've attached a 1 pager info doc but will highlight that the S384A permits are specifically for occupation of structures, navigational aids (buoys, lights, fog signals), exclusive occupation areas such as

safe anchor areas, and some structures such as wharves. Other activities such as dredging, discharging and land reclamation etc are RMA processes being covered by MFE in the RM reforms. We are undertaking this process with MFE, and I acknowledge that cultural impacts are holistic and while for example the scope of this s384A approach is narrow to the points above, any feedback we receive on the wider impacts and Te Tiriti requirements we will still receive and share with our MFE colleagues.

## Kia ora korua

Thanks for taking the time to meet with me this afternoon. I really appreciated it.

In terms of action points, I note Rebecca that you will send to me PDFs of:

- 1. The points where the navigational aids (buoys/beacons and lights) are that guide ships into and out of the port; and
- 2. The area which is designated for safe habouring for ships from unsafe weather which extends to the harbour master then being able to guide them into the port area if able.

In terms of the first issue, I would also like to see the structures and how those structures are locked into the seabed. As I said, I walk the Waikanae beach and see both the navigational aids and the area where ships harbour – on top of the cruise ships that just park out in the bay.

With regard to the permits, I note:

- 1. In 1992-1995 I led Te Runanga o Turanganui a Kiwa which at that point in time represented Ngai Tamanuhiri, Rongowhakaata and Te Aitanga a Mahaki;
- 2. During that time we opposed:
  - a. The dredging and discharge by dredgings of Port Gisborne
  - b. The pipeline of the Gisborne District Council; and
  - c. The discharge of the Gisborne District Council through their pipeline on the seabed.

This background does not relate specifically to these permits because, as you noted, these permits were done by the Minister of Transport and I don't recall being consulted on those at the time. But I stand to be corrected.

Having said that, the issues outlined by my people from 1992 to 1996 are still relevant to all activities on the seabed and within the moana.

My people who gave evidence on both resource consent applications 30 years ago included Rapiata Ria (Senior), Nona Haronga, Kingi Smiler, Peter Gordon, Vivienne Pohatu and Nuna Wyllie. I met with them all and recorded their evidence, and was there when the evidence was presented in the independent commissioner led committee and the Planning Tribunal before Judge Turner.

Relying on memory from 30 plus years ago.

Nuna Wyllie is the only person still alive of those who gave evidence. Along with Vivienne Pohatu he outlined, on behalf of Ngai Tamanuhiri, the tide movements and all the fishing grounds that would be affected by the discharge of dredgings back into the moana. He had a map that was produced.

There were a number of agreements reached on each application by agreement (with the Port) or through the Planning Tribunal/Environment Court.

Separate hapu and lwi have taken their own action subsequently with the Port and/or Gisborne District Council or its LATEs in this area (including tributaries that affected by the Port) based on where the activities took place and the impacts on the catchment, moana and the life in the catchment and moana. These include:

- 1. Ngati Oneone & Te Runanganui o Ngati Porou
- 2. Rongowhakaata
- 3. Ngai Tamanuhiri

- 4. Te Aitanga a Mahaki
- 5. Te Runanga o Turanganui a Kiwa

I have copied in the key people of each of these groups and have included my Chair Pehimana Brown for Te Aitanga a Mahaki instead of Dr Ian Ruru who led a lot of the activities at the time. So the people copied in are:

Subject to and without impacting on the decision of any other hapu or lwi, the position of Te Aitanga a Mahaki is:

- 1. These permits are necessary to ensure safe entry in and out of the port, and safe habouring during inclement weather;
- 2. Tangata Whenua needs to be involved in the shape of how the permits are implemented to ensure the impacts are understood and where possible mitigated including:
  - a. Impacts on the mauri of the moana;
  - b. Impacts on the physicial seabed;
  - c. Impacts on the kaimoana including taunga ika (fishing grounds) of tangata whenua.
- 3. Tangata Whenua must be involved in the design and implementation of the navigation aids and harbouring sites and ongoing monitoring.
- 4. The best vehicle for Te Aitanga a Mahaki to achieve this is through the Local Leadership Board (details attached) as an impact on the moana affects multiple whanau, hapu and lwi.
  - a. Te Aitanga a Mahaki would ensure, over and above any separate agreements that they reach, Ngati Oneone is a part of the design and implementation in the Local Leadership Board through Te Aitanga a Mahaki.

I will touch base with the other Iwi CEs and look to make a formal submission on this issue but would appreciate seeing and inputting to the final advice that goes from MOT and MFE based on this feedback. I acknowledged that you may advocate something but ultimately it is Ministers who determine these matters.

I look forward to your response.

It is disappointing that no one from MfE was able to participate given that it was forwarded to me by an MfE contractor when they realised that I had been left out of direct contact.

# ATTACHMENT A – FEEDBACK ON EXTENDING EXISTING PORT COASTAL PERMITS UNDER THE RESOURCE MANAGEMENT ACT

## Te Rūnanga o Arowhenua

- Ngāi Tahu are Tangata Whenua of the Canterbury Region. Ngāi Tahu means "people of Tahu". Ngāi Tahu is the iwi comprised of Ngāi Tahu Whānui; that is the collective of the individuals who descend from the five primary hapū; Ngāti Kurī, Ngāti Irakehu, Kati Huirapa, Ngāi Tūāhuriri and Ngāi Te Ruahikihiki. The Charter of Te Rūnanga o Ngāi Tahu established under the Te Rūnanga o Ngāi Tahu Act 1996 (the Act) constitutes Te Rūnanga as kaitiaki of the tribal interests.
- 2. Papatipu Rūnanga are defined in Section 9 of the Act. This includes Te Rūnanga o Arowhenua (hereon referred to as Arowhenua). Aoraki Environmental Consultancy Limited (AEC) is a legal entity that has been given the mandate by Arowhenua Rūnanga to represent their interests on all environmental matters.
- 3. Ngāi Tahu holds and exercises rangatiratanga within the Ngāi Tahu Takiwā (Takiwā) and has done so since before the arrival of the Crown. The Crown and Parliament have recognised the enduring nature of that rangatiratanga through:
  - a. Article II of Te Tiriti o Waitangi (Te Tiriti);
  - b. the 1997 Deed of Settlement (Deed of Settlement) between Ngāi Tahu and the Crown; and
  - c. the 1998 Ngāi Tahu Claims Settlement Act (NTCSA) in which Parliament endorsed and implemented the Deed of Settlement.
- 4. As recorded in the Crown Apology to Ngāi Tahu in the NTCSA, the Ngāi Tahu Settlement marked a turning point, and the beginning of a "new age of co-operation". The Crown apologised for its "past failures to acknowledge Ngāi Tahu rangatiratanga and mana over the South Island lands within its boundaries" and confirmed that it "recognises Ngāi Tahu as the tāngata whenua of, and as holding rangatiratanga within, the Takiwā of Ngāi Tahu Whānui". The expectation of Ngāi Tahu is that, regardless of the content of any specific legislation, the Crown acts consistently at all times with that overarching pledge, Te Tiriti and Ngāi Tahu rangatiratanga.
- 5. This is feedback from Te Rūnanga o Arowhenua, the representative body of the Tangata Whenua and who hold manawhenua in the traditional takiwā that includes the area between the Rakaia River and the Waitaki River. The takiwā includes PrimePort, the port of Timaru, which is one of the port companies that Government is looking at granting an extension under section 384A of the Resource Management Act 1991 for an additional 20 years.
- 6. The feedback provided reiterates the desire of Arowhenua to see te taiao, including the coast and coastal water protected to maintain natural processes; protect and enhance kai moana, and improve coastal water quality.





## Feedback

### Engagement with Ngāi Tahu Whānui

- 7. The engagement on this proposal has fallen well short of our expectations of engaging with Arowhenua as Papatipu Rūnanga and Te Rūnanga o Ngāi Tahu as a Te Tiriti partner. Arowhenua is deeply disappointed in the processes of engagement with us in respect of these proposals.
- 8. As a Te Tiriti partner, and kaitiaki holding Tino Rangatiratanga within the Ngāi Tahu takiwā, Arowhenua and Ngāi Tahu are uniquely placed to engage with the Crown on pragmatic solutions that ensure sustainability of te taiao for future generations.

### Te Taiao

- 9. Arowhenua recognises the importance of PrimePort Timaru to the Timaru community and to the transportation network of New Zealand. However, Arowhenua is concerned this approach appears too blunt and the extension of occupation by 20 years will:
  - Allow an automatic, 20 year duration which will give rise to intergenerational issues;
  - Potentially further complicate issues relating to the extent to which s384A applies in terms of the area occupied and adjacent and managing the effects from the occupation of the space;
  - The extent to which it captures and would continue to permit pre-1991 structures that should be removed or replaced; or promotes exclusive occupation rights and does not allow for consideration of other compatible uses;
  - Does not account for coastal plans that are overview for review and could remove the ability to develop Timaru Port centric provisions that better account for the aspirations of the port alongside those of the community and the coastal environment.
  - Impact on the ability to create a fit for purpose regulatory environment that addresses Treaty settlements, climate change and the need to manage the Timaru coastline and its resources.
  - Potentially erodes or undermines the relationship that Arowhenua has begun to establish with PrimePort Timaru to work on issues of common concern.

## Recommendations

- 10. Arowhenua recommends the following actions:
  - i. Amend the proposal to extend the coastal permits granted to port companies under section 384A of the RMA to no more than 10 years;
  - ii. During the no more than 10 year period undertake a review of the legislative and regulatory framework for managing the port at Timaru and alongside Arowhenua Rūnanga, implement an improved framework for the Port and te Taiao.
  - iii. That any process to introduce or modify consent conditions on permits for PrimePort Timaru includes the requirement to engage with Arowhenua.

# Extending existing port coastal permits under RMA

### **Submission**

The submission by the Takahiwai Maori Committee, Est. 1977 clarifies the impacts of the Ministry of Transport's extension of Northport Ltd's port coastal permit under the Resource Management Act upon the kainga and communities at Takahiwai and Te Poupouwhenua, in the following ways.

When the first voyagers arrived in Aotearoa, they sought sheltered bays in which to draw up their canoes and come to land, hundreds of years later the first Europeans did the same. Our harbours are and have always been coveted and contested sites for navigation, industry, fishing, recreation, and settlement. Harbours are sites of intersection between land, freshwater and coast and often contain highly significant biodiversity, landscape and natural values, each with different legal treatment including: Land—generally, private owned with clear boundaries and regulated by territorial authorities; and—Water & Coast–generally now 'owned' by anyone but with rights of access and use regulated by regional councils and government agencies. Historically they are important places of meeting, negotiation and exchange. The law relating to harbours is complex reflecting a web of competing and diverse interests. Consider for a moment that Maori antiquity—Tangaroa the god of the sea, Tane Mahuta the god of the forest, Tawhirimatea the god of the winds, Papatuanuku the earth mother] and Ranginui sky father], at bottom—is not protected from the harmful effects of Northport Ltd.'s visions for growth at Te Koutu [Marsden Point], Te Poupouwhenua.

Over 30 years, while Northport's efforts to remake the harbour for the port industry's increasing profitmaking, the Te Parawhau Hapu has been alienated from te reo Maori me nga tikanga [Maori language and culture], continual land grabs of the tribal land and sea, wetlands, sacred sites, and fish, birds, and plants at Te Koutu, Te Poupouwhenua. Northport's legacies are profoundly discriminating, inequitable, and unequal; a form of industrial colonisation of the land and sea, the fresh and the coastal water, the marine, bird, and plant life, and the Ahikaaroa living on the ancestral land in Takahiwai. The rare and endangered species, Indigenous flora and fauna, marine creatures, and birds at Te Koutu, Te Poupouwhenua are at risk of the multiple potential harmful impacts of

industrial invasion, from the noise of the machinery that harms wildlife, to the activity killing animals and plants on the seabed that are ancient and cannot be remade.

Of course, the Tangata Whenua, Te Parawhau Hapu, prefer to be the designers of our relationship with the Ministry of Transport and Northport Ltd. Liberal democracy exists because we all think differently. The Hapu, the Ministry, and Northport's people bring different experiences, values, and aspirations to our ideas about what governments and their agencies should and shouldn't do. There is no objective truth in the business of government. Democracy developed to manage these differences. Sometimes, however dominant populations use the democratic system to protect their self-interest rather than accommodate the rights and interests of others.

On a general policy position, the modern paradox proclaimed by the Waitangi Tribunal 2017 accepts that a Maori presence and ancestral values underpin Resource Management Act matters. The Te Parawhau Hapu understands from the modern paradox that the regional interests actively disrespect the local, the global interests disrespect the local, the regional, and the national. All citizens, though, are entitled to a "parity of esteem"; in other words, a "fair go" that strikes a reasonable balance between the interests of the Hapu, Maori, the Ministry, other publics, and private interests. Thinking about what general policy should achieve from an Indigenous cultural perspective or through an Indigenous language should not be a disadvantage. Otherwise, the Te Parawhau Hapu lose our rangatiratanga and mana, and the wildlife lose our 'voice', and all of life loses equal respect.

It is fair, then, to ask the Ministry to "recognise and provide for" the whanaungatanga [relationship] of the Te Parawhau Hapu as the Tangata Whenua to Te Koutu, Te Poupouwhenua, and our Whanaungatanga with all life that will be affected by the Ministry's action. This is a "strong direction" as per the Privy Council in McGuire versus the Hastings District Council; as well as the Supreme Court wherein Justice Joe Williams in Trans-Tasman Resources Ltd described relationships of this type as: ... the longest-standing human related interests in that place. As with all interests, they reflect the relevant values of the interest-holder. Those values—mana, whanaungatanga and kaitiakitanga—are relational. They are also principles of law that predate the arrival of the common law in 1840. No reira, ka mihi.
