





Email wording

The attached Cabinet paper, for consultation, seeks Cabinet's agreement to a package of changes to reform transport governance in Auckland.

Issues relating to transport governance in Auckland were set out in a previous Cabinet paper (considered by ECO on 24/9/2024). Cabinet agreed that I consult with the Mayor of Auckland on a proposal for reform (ECO-24-MIN-0217).

I have concluded discussions with the Mayor and worked on further detail of the proposal.

The key decisions I am seeking agreement to are:

- reconstituting the Auckland Regional Transport Committee (ARTC) to hold the strategic transport planning function in Auckland, with membership comprising Ministerial appointees and Auckland Council elected members with an independent Chair, jointly appointed by the Minister of Transport and the Mayor of Auckland
- requiring the ARTC to develop a 30-year integrated transport plan, and to publicly consult on this, with Cabinet and Auckland Council agreeing to the final plan and to develop the Regional Land Transport Plan (RLTP)
- 3. transferring approval of the RLTP and policy functions (including Road Controlling Authority powers) to Auckland Council (from Auckland Transport currently)
- 4. providing for specific local transport functions to be allocated to Auckland Council's local boards

Summary of Report

CAL MEORMATION ACT 1982 Key findings of the 2020 independent review of Auckland Council's CCOs lead by Mirriam Dean KC, are summarised below:

Performance of Auckland Transport

- The report noted Auckland Council is the only local authority to not have a role in • developing or approving transport strategy through the Regional Land Transport Plan (RLTP) and that the 2013 legislative change was wrong in principle. The report recommended a model of joint responsibility for the RLTP between Auckland Council and Auckland Transport. This did not involve legislative change.
- The report found Auckland Transport had improved transport services and infrastructure • but was challenged to deliver minor capital projects in line with public expectations. It recommended Auckland Transport review their process for minor capital projects and consider greater involvement of local boards in decision-making for these projects.
- The report considered whether Auckland Council, instead of Auckland Transport, should be the road controlling authority (RCA) for Auckland as is the case for territorial authorities in other regions. However, it concluded that this would lead to an "unsustainable burden" on Auckland Council.
- The report found that Auckland Council and Auckland Transport both being able to make • transport related by-laws was "unnecessary, cumbersome to administer and a source of

confusion". It recommended establishing an agreed approach to delineating by-law responsibilities between entities (which is in the process of being implemented).

• The report noted the process for Auckland Transport accessing funding from the National Land Transport Fund through NZTA was lengthy and time consuming with funding approvals for projects in the NLTP taking between 3 months and 2 years. It recommended Auckland Council and Auckland Transport work with central government to streamline funding processes.

CCO Model: Accountability and Culture

- The report considered whether CCOs, such as Auckland Transport, are sufficiently accountable to Auckland Council and the community. Overall, the report found that while Auckland Council had all the necessary levers to ensure accountability, these levers were not being used effectively. The report provided recommendations to improve accountability outcomes.
- The report noted that the culture of CCOs contributed to "silo" thinking where individual CCOs operated independently, and that collaboration across the Auckland Council group was limited. The report identified that CCO culture needed to change to improve how they consult, engage with and respond to Auckland Council and the community.
