Consultation on Euro 6/VI vehicle emissions standards

Consultation on the Land Transport Rule: Vehicle Exhaust Emissions Rule 2007 (the Rule) ran from 11 May 2023 – 22 June 2023. The proposed amendments would strengthen the emissions standards required for vehicles entering New Zealand (to Euro 6 for light vehicles or Euro VI for heavy vehicles, and their international equivalents). The consultation proposed to transition gradually towards Euro 6/VI between 2024 and 2028.	Next steps: We will provide you with a Summary of Submissions and advice on changes to the Rule in the week ending
The emissions standards set limits for harmful pollutants in vehicle exhaust emissions, such as nitrogen oxides and fine particulates, which can cause significant harm to human health (they are not related to CO2 or greenhouse gas emissions). New Zealand and Australia have the weakest harmful emissions standards of developed countries, and we would be the last to move to Euro 6/VI or an equivalent.	1 August 2023.
We received 77 submissions, with broad support for improving our emissions standards. Many submitters have raised new information and valid concerns with the proposed phase-in of Euro 6/VI in relation to proposed timelines, divergence from Australia's timelines, and the equivalencies of Euro standards with other international standards (Japan, United States of America, Australia).	
We had proposed that you sign the Rule by September 2023. However, if the changes required following consultation are significant, you would require further Cabinet approval prior to signing the final Rule, which may push the signing of the Rule beyond the General Election.

MetService Quarterly Report April – June 2023

The Ministry has received MetService's quarterly report to the Minister of Transport for the period 1 April 2023 to 30 June 2023. We have provided key highlights from the report for you below.

Each quarter, MetService has to achieve two Key Performance Indicators (KPIs) which are Probability of Detection (POD) – the ratio of correctly forecast events to observed events, and False Alarm Ratio (FAR) – the ratio of forecast event that did not occur to the number of events forecast. MetService achieved their two key measures for this quarter as well as the full year performance target. The radar network had several outages due to various reasons but still averaged 99.3% for the quarter.

The warning performance was generally very good this quarter with several local-scale events occurring in Northland and Auckland in early May 2023 where rain caused flooding, including a flash flood in Whangārei.

The Wellington radar returned to service in May 2023 and the Radiofax service ceased on 1 July 2023. The MetService Board welcomed a new Board member, Dr Te Tiwha Puketapu and appointed Paula Jackson as the Chair of the Board. On 17 May 2023, 14 students of the 2021-22 Master of Meteorology (MMet) cohort have graduated as part of the MMet programme that is run in New Zealand in partnership with Te Herenga Waka – Victoria University of Wellington. Lastly, Stephen Hunt (Chief Executive) and Norm Henry (Chief of Science and Innovation) attended the 19th Session of the World Meteorological Congress where World Meteorological Organisation (WMO) members agree on initiatives that they will fulfil in the coming years to meet the purpose and vision of WMO - that all nations are served by early warnings and are resilient to extreme weather and other environmental events.

Cyclone Recovery

Policy function (excluding legislation)

This function is responsible for providing policy advice to Ministers, excluding policy advice on legislation which is managed by the legislation function.

We have been working with Treasury to support the drafting of a paper on the National Resilience Plan to be lodged by the Minister of Finance while we continue to work on a draft Cabinet paper with respect to the rebuild of transport infrastructure following the severe weather events. Further information on this is available in the investment function update below.

For the draft Cabinet paper on the rebuild of transport infrastructure, we will provide an updated version of the draft Cabinet paper to your Office on 26 July 2023 ahead of Ministerial consultation.

Legislation function

This function is responsible for providing policy advice to Ministers on cyclone recovery legislation, including Orders-in-Council (OiCs), and for the implementation of cyclone recovery legislation.

Function lead: Jessica Ranger, Manager, Placemaking and Urban Development

The Parliamentary Counsel Office (PCO) informed us earlier this week that they would not be able to provide us with all three draft OiCs in time this week, given constrained drafting resource on their end. The three OiCs are part of Tranche 4 OiCs.

After some further discussions with the PCO, they have informed us that the OiC with modifications to the Land Transport Management Act (LTMA) 2003 would be provided to us in time for the Minister's approval to be submitted to the Review Panel and the Regulations Review Committee. This means that this OiC can remain in Tranche 4. The briefing has now been provided.

The other two Oics (for Waka Kotahi and KiwiRail works) will be able to be drafted in time for Tranche 5 timeframes.

Investment function

This function is responsible for advising, managing, and implementing Budget decisions to support the cyclone recovery, and managing any other investment activities to support the cyclone recovery.

Over the last week we have been working with Waka Kotahi and KiwiRail to refine which components of their respective funding requests are critical to enable recovery works to continue while the National Resilience Plan (NRP) funding process is formalised, and to ensure adequate funding is available to prepare business cases for rebuild proposals. At a high level, the components of funding that each entity has requested for these activities is as follows:

Maritime mini-omnibus consultation

ADS-B Grant Scheme closure

The CAA opened a grant scheme for eligible private aircraft owners to claim up to \$3000 plus GST to install Automatic Dependent Surveillance-Broadcast (ADS-B) surveillance systems as part of the New Southern Sky programme in March 2020. The scheme was established to help aircraft owners meet the equipage requirements specified for all aircraft flying in a controlled airspace.

The ADS-B Grant Scheme closure on the 30 June 2023 was well signalled, with a record number of claims paid out for the month (198). A further 214 claims were received in the last few days of June 2023 and these will be paid out during July 2023.

There were 85 incomplete applications when the scheme closed. The CAA advised these applicants that the scheme has closed and no further payments can be made. This has resulted in a number of dissatisfied applicants who may seek to raise the issue publicly or through political channels, with the aim of seeking to have grants paid out.

Funding Review consultation now live

Following Government approval, Maritime NZ has opened public consultation on proposed changes to Maritime Levies and Oil Pollution Levies. This is the first funding review in five years, as the Government agreed to delay the mid-point review due to COVID-19 impacts. To develop the proposed changes, we worked closely with the sector and looked closely at areas where additional levies funding will need to be invested between July 2024 and June 2030. The consultation is open until 16 August 2023. During this time, we will hold webinars to go over the proposals in the consultation document, provide stakeholders the opportunity to ask questions and encourage their submissions. Following the consultation, we will carefully review and analyse all submissions, then prepare advice and recommendations on levies changes before the end of 2023.

Maritime Industry Forum

The Maritime Industry Forum met online last week. The Forum is an opportunity for commercial maritime sector leaders to exchange information and views about the current key issues impacting the industry, to agree on priorities, and collectively work on solutions. Membership includes representatives from all parts of the commercial sector, and the Ministry of Health, with representatives from other government agencies attending as issues require. It is chaired by Maritime NZ.

The Forum reiterated that its priority issues continue to be in the areas of seafarer welfare and workforce issues. The Forum agreed to convene a sub-group to undertake a stocktake of current measures and work in the area of seafarer welfare, and received an update from Maritime NZ covering cross-industry work underway in the area of workforce. Each Forum member spoke to their current concerns and issues, with much cross over evident in the sector. The next meeting will pick up on one of those priorities, with the planned attendance of Customs to discuss changes on the border, and will also include a workshop session designed to extend and document common issues across the sector.

Medical emergency aboard Singapore vessel Maersk Rio Delta

The emergency "helivac" of a seafarer needing urgent appendix surgery highlights the complexities that can arise in supporting international seafarer welfare.

The chain of events started with the Master of Singaporean-flagged ship, *Maersk Rio Delta,* advising the Bay of Plenty Harbourmaster that a crewmember was seriously ill with suspected appendicitis. The Harbourmaster contacted Maritime NZ because, while the ship was en-route to the Port of Tauranga, it was still some distance at sea, there were no berths immediately available, and it was unable to divert to Auckland.

Maritime NZ's Regulatory Operations group and Rescue Coordination Centre NZ worked together with the Harbourmaster, the ship's Master, the ship's representatives in New Zealand who worked with the overseas operators, Coastguard, a rescue helicopter, and medical services, including getting confirmation of where the crewmember could be admitted for urgent surgery, which turned out to be in Auckland.

After the Master's initial plan of transferring the crewman to the nearest hospital via a Coastguard vessel was ruled out, a rescue helicopter was dispatched. The patient was winched off the ship at sea, emergency medical assistance was provided on the helicopter, and he was flown to Auckland Hospital for surgery. He has now been discharged and is recovering well. Without effective coordination of all involved, the outcome for the seafarer could easily have been tragic.

Maritime NZ in the Media

A local Northland newspaper is following up about the wreck of the *Niagara* and has asked questions around budget bid processes and whether Maritime NZ has responded to any reports of oil or had to clean up any oil. The reporter also contacted Minister Allan's Office. Maritime NZ will provide responses to her requests. Minister Allan's Office gave her an update on its position on the Niagara.

DRURY STATIONS

The High Court confirmed to KiwiRail on 13 July 2023 that the application by developer MADE Group for a Judicial Review concerning the process leading to the site selection of Ngākōroa Station has been dismissed. This station is being built as part of the New Zealand Upgrade Programme (NZUP). The High Court hearing was held in March 2023.

KiwiRail understands the High Court has informed media of the outcome and will upload it on its website.

The below is KiwiRail 's media holding statement which will be used only if requested by media:

KiwiRail and its partners Waka Kotahi and Auckland Transport welcome the decision to dismiss the Judicial Review on the proposed location of Ngākōroa Railway Station (Drury West). We intend to continue with the consenting process currently underway for the station.

This is a positive outcome, as it means KiwiRail will not need to restart the 18-month public consultation process which would delay the delivery of the station

INTERISLANDER

Interislander

Kaiarahi has left New Zealand for dry dock in Singapore from 1 August 2023. It will be in dry dock for 28 days, before returning to New Zealand. This is scheduled maintenance and is key to KiwiRail's programme to lift service reliability for the existing Interislander fleet.

OIA release by Maritime New Zealand,

Maritime New Zealand (MNZ) will be releasing information to TVNZ, Stuff and Herald on 21 July 2023 seeking correspondence between MNZ and Kiwirail about safety and maintenance concerns on ferries. KiwiRail's response will be to note that:

- Safety is a priority for Interislander, and we respect MNZ's role as regulator in delivering safety.
- We have worked to enhance safety and reliability processes across our fleet since the Kaitaki loss of power early in 2023.
- Six of the nine non-conformities found in the MNZ audit have been resolved, and the other three will be closed off at our next annual audit. None concerned the safety of our fleet.
- The correspondence from MNZ raised the issue of Interislander seeking exemptions, which are part of normal business, and that on average Interislander applies for fewer than 10 exemptions a year (outside of the intense COVID-19 period).
- Requests for exemptions are a way to proactively raise potential issues of non-compliance with MNZ to ensure that MNZ are satisfied that we are safe to sail.

IREX UPDATE

iReX Construction

The iReX team has worked with Marlborough Roads and Waka Kotahi to ensure good detour arrangements are in place, and are talking widely with the community, ferry passengers, tourist operators and commercial companies to ensure road users are well informed.

iReX Ships

KiwiRail and Hyundai Mipo Dockyard recently undertook 3D model reviews, indicating the detailed level of design for the new ships. The team had a workshop each day with one of the design departments: accommodation, hull outfitting, piping, machinery and electrical. The focus was on safe operations, analysis of arrangement space, accessibility for maintenance and inspection of anchor handling arrangements.

LONG DISTANCE PASSENGER TRAINS

Te Huia Signal Passed At Danger (SPAD)

Following the issuing of the condition order, KiwiRail has been working with Waka Kotahi on finding a common-sense, safe solution that will allow Te Huia to resume travelling into central Auckland as soon as possible.

We met with Waka Kotahi on 18 July 2023 and provided an update on our investigations into the incidents.

This included KiwiRail's outcomes and recommendations, an update on the European Train Control System (ETCS) implementation timeline, and discussed an agreed a joint approach to tackling SPADs.

We also provided our Auckland Metropolitan network SPAD risk assessment and our "so far as reasonably practical" statement referencing Section 7 of the Railways Act which holds that 'a rail participant must ensure, so far as is reasonably practicable, that none of the rail activities for which it is responsible causes, or is likely to cause, the death of, or serious injury to, individuals'. We are promoting alternative arrangements to the requirement for ETCS, which is a bespoke technology set which will take 1-2 years to design, install, commission, and certify.

Waka Kotahi will review the information provided and will come back to us with any further questions.

On 20 July 2023, Waikato Regional Council hosted a closed-door meeting in Hamilton with regional councillors and local mayors. They requested KiwiRail and Waka Kotahi as regulator attend to explain the recent SPADs, responses to it and to understand the decision by the regulator to impose the condition. KiwiRail attended, as Waikato is our customer. The regulator declined the invitation; however, the Waikato and Bay of Plenty Waka Kotahi Regional Director attended.

Passenger numbers

After a very successful period which has seen Te Huia carry well above its target numbers, there has been a sharp decline in passenger volumes since the condition.

The week prior (3 July – 7 July 2023) saw an average of 355 passengers carried across the weekday services.

For the four days where Te Huia has only travelled to Papakura, we have seen an average of 254 passengers, and the average has been buoyed by a high number of passengers being carried on the Thursday service prior to Matariki. Passenger numbers for 17 - 18 July have been 188, and 166 respectively.

SAFETY CULTURE

As previously reported, KiwiRail is partnering with global safety leadership firm dss+ (formerly DuPont Safety Solutions) to complete a whole of KiwiRail safety leadership cultural and maturity assessment programme.

We are now beginning to share the results of the survey with our teams on the ground, through "mirror walk" sessions. To date almost 300 staff have attended a session and we will continue the roll these out over the next couple of months.

The end goal is to produce a KiwiRail focus on the right initiatives to build a safety mindset, visible leadership, critical risk and controls, front line engagement and the right assurance and accountability discipline, to ensure we work to care and protect our people and build a high-performance safety culture.

We will keep your Office informed as this work progresses.
