I would like to see any information provided to or requested by the Minister of Transport on this issue and evidence of any work requested relating to this matter."

Where you have asked for "any information provided to or requested by the Minister of Transport on this issue," we have interpreted your request to be:

"All advice provided to or requested by the Minister of Transport from the Ministry of Transport regarding the Government's commitment to 10,000 public EV charge points by 2030."

With respect to this part of your request, we have identified 54 documents that fall in scope and these are listed in the document schedule attached as Annex One. The schedule outlines how the documents have been treated under the Act.

Certain information is withheld or refused under the following sections of the Act:

With regard to the information that has been withheld under section 9 of the Act, I am satisfied that the reasons for withholding the information at this time are not outweighed by public interest considerations that would make it desirable to make the information available.

Where you have asked for "evidence of any work requested relating to this matter," we emailed you on 30 September 2024 to clarify the information you sought but did not receive a response. We have therefore interpreted this part of your request as:

"Evidence of all work relating to the Government's commitment to 10,000 public EV charge points by 2030."

From an initial scoping exercise, we identified more than 1,900 documents and emails that may be captured by this part of your request. Allocating a staff member to undertake research and collation for this number of documents would have an adverse impact on my team's ability to carry out its other functions. Therefore, I am refusing this part of your request under the following section of the Act:

18(f) that the information cannot be made available without substantial collation or research

The documents identified in response to the first part of your request (detailed in Annex One) cover the key advice developed by the Ministry of Transport on the Government's commitment to 10,000 public EV charge points by 2030. If there are other specific document types or information you are interested in, we are happy to work with you to scope another request.

You have the right to seek an investigation and review of this response by the Ombudsman, in accordance with section 28(3) of the Act. The relevant details can be found on the Ombudsman's website www.ombudsman.parliament.nz.

The Ministry publishes our Official Information Act responses and the information contained in our reply to you may be published on the Ministry website. Before publishing we will remove any personal or identifiable information.

ROUNDTABLE MEETING WITH ELECTRIC VEHICLE CHARGING PROVIDERS

Background information

5

- In our previous advice, we have noted key market barriers to EV charging infrastructure rollout:
 - **Regulatory barriers**, including the high costs of connecting to electricity networks and long timeframes to connect.
 - **Demand/utilisation risks** which limit commercial incentives for the private sector to invest in EV chargers in locations with low demand.
- Those barriers are consistent with what members of the industry have previously expressed to you, and we expect they will raise again in this meeting:
 - The number one priority across all charge point operators (CPOs) is addressing the regulatory barriers associated with connecting to the electricity networks, which comes in the form of connection costs and multi-step processes. CPOs have highlighted that the necessary pace of charger rollout cannot be achieved without addressing regulatory challenges.
 - The industry has also pointed out the need for sustained investment in public charging infrastructure and ensuring that infrastructure is available ahead of demand in remote areas with lower demand.
- The Supercharging EV Infrastructure work programme and the cross-agency Taskforce have been established to coordinate the government's work to address these barriers.
- The work related to reducing the high costs of connections for CPOs to install charging stations is underway by the Electricity Authority as identified in *Electrify NZ* policy. The work is reported on under the *Electrify NZ* programme and MBIE is monitoring progress.

- To further inform this advice, on 17 May 2024, officials met with CPOs to better understand their concerns and identify potential options.
- 7 In this meeting, key themes raised by industry included:

- The importance of looking at regulatory barriers and the co-investment model holistically.
- Feedback on various approaches to recycling Crown capital, including the potential efficacy of different loan or equity models.
- Their preference for an open procurement approach in which the market leads investment decisions (in terms of charger types and location).
- Views on how public value and value for money assessments can be built into the co - investment model, including what type of criteria applications should be assessed against.
- The Taskforce will continue to engage with the industry as advice is developed on the co-investment model.

This meeting is an opportunity to seek further views from CPOs on the co-investment model

- 9 We expect the ongoing discussion around connection costs and the work on the coinvestment model to be the main topics of discussion.
- 10 We suggest you use this meeting to test with CPOs:
 - How can we practically recycle Crown capital to support further investment (for example, through concessional loans)?
 - What do they expect will be the consequences of recycling Crown capital for the speed and spread of the network rollout?
 - How can we design assessment criteria to ensure we maximise value-formoney from Crown investment?

ANNEX 1: TALKING POINTS

Addressing barriers to connect to electricity networks


- Addressing barriers to connection costs and timeframes to connect to electricity networks are key priorities for me.
- I am looking closely at the work underway on at the Electricity Authority that could help address this issue, particularly its work on regulating connection pricing for electricity distribution businesses (EDBs). Work includes regulating to limit the type of costs that may be recovered by EDBs from new EV charging point operators and options to manage first-mover disadvantage.
- You may be aware of the Electricity Authority's new paper, Distribution Pricing
 Reform: Next steps, which was released on 7 May 2024. The Electricity Authority
 plans to develop proposals to amend the Electricity Industry Participation Code 2010
 to regulate connection prices and ensure electricity distribution businesses are setting
 prices at efficient levels.
- This work should help alleviate some of the concerns you have raised about high connection charges to install EV charging stations, and concerns about optimising your investments.
- The Electricity Authority has signalled it will be developing draft proposals through a working group and then release a consultation paper in October this year. I encourage you to provide your feedback through the consultation paper.
- The Electricity Authority has also established a Network Connections Technical Group to assist the Authority with Code changes to improve the efficiency of network connection.


Government co-investment in EV charging infrastructure.


- I intend to make some changes to the government co-funding model so that private investment in the EV charging network is maximised. As the market matures, I want to see public EV charging providers become a profitable and economically resilient sector.
- My view is the main role for government should be to facilitate private investment by
 ensuring the regulatory environment is fit-for-purpose. However, I recognise there is
 likely to be an ongoing role for some government co-investment targeting projects
 that face the biggest market barriers and that are needed for an effective, nationwide
 network.
- I note that a cross-agency Taskforce has been established to coordinate the
 government's work relating to the EV charging programme. I am aware that many of
 you have recently engaged with the Taskforce and provided valuable feedback
 regarding the co-investment model.
- Officials will continue to engage with you as they develop their next phases of advice to ensure we develop a co-investment model that is workable and effective for industry.
- I am interested to hear your views on how to maximise private investment and how
 we could feasibly recycle Crown capital to support further investment (for example,
 through concessional loans).


• I am also interested in how we ensure value-for-money from public investment. I note the co-investment model could use key assessment criteria to assess value for money. What criteria do you think the Government should consider when assessing applications?





After our meeting with MBIE and EECA this morning on the attached paper we did want to check if the paper should have a more comprehensive policy work programme for EV charging, if that is the case MoT would be the most appropriate lead with support from MBIE and EECA (originally we were thinking this paper would mainly focus on the EECA funding round, electricity regulatory policy timelimes, and the timelines for the CBA) – however after re-reading the commissioning email and having a discussion there is an opportunity to form this up into a bit more of a comprehensive paper.

Note if this paper was to me more comprehensive than (just an update and recs on EECA funding round, electricity regulatory policy timelimes, and the timelines for the CBA) we will need an extension of at least two weeks to put this paper together. This will give us time to do more work on what policy options and issues we think should be in scope of the work programme and discuss this matter with Treasury.

Please find a response below regarding your request for a brief email outlining the approach to the CBA and rationale for the expected timeframes.

Resourcina

- The Ministry of Transport is progressing work on a cost-benefit analysis (CBA) for public EV charging infrastructure, in line with commitments in the National-ACT Coalition Agreement.
- The bulk of the analysis will be completed in house at MoT, with input from relevant government agencies (e.g. EECA, NZTA, MBIE, Electricity Authority, Commerce Commission) and key external stakeholders (e.g. Drive Electric).
- There is a quick turnaround piece of research currently being commissioned through NZTA's Transport Sector Research Programme. This will be due mid-year and is estimated to cost a maximum of \$130,000. It will not create any new data but will bring together domestic and international research relating to the relationship between EV charging infrastructure and EV uptake.

Timeframes

- The first key deliverable from the analysis will emissions impacts estimates. These are required in August 2024 to meet the publication deadline for ERP2.
- The final CBA and report will be completed in November 2024.
- This is the minimum feasible timeframe to produce a robust CBA on EV charging. There are some key challenges to quantify costs and benefits, including uncertainties around policy changes and their impacts, and a lack of existing
- The focus for the first half of 2024 will be on developing a robust methodology and data inputs. This will be informed by the above research and by engagement with relevant experts (both in government and external).

High-level approach

- · Our current proposed approach would centre on developing an 'EV charging investment and funding module', building on existing EECA modelling. This module would use data on EV installation costs, EV charger revenues, and intervention impacts to model the counterfactual and impact of interventions on total number of chargers, cost of chargers and Government funding requirements.
- The 'EV charging investment and funding module' would then feed into a redeveloped Clean Car CBA model to produce CBA outputs and other metrics (such as impact on EV uptake, emissions impacts and marginal abatement cost).



Kia ora Dom,

We're working with MBIE on the Supercharging EV Infrastructure Cabinet paper that they are holding the pen on.

A sticking point is the framing of the previous EV charging strategy and work programme published in October 2023:

'Charging Our Future: National electric vehicle charging strategy for Aotearoa New Zealand 2023 - 2035' was published in October 2023 following agreement by Cabinet [DEV-23-MIN-0206 refers]. While the priorities identified in this paper are my immediate focus, it may be valuable to update the previous strategy and work programme to provide clarity to stakeholders on the government's EV charging priorities. I will consider advice on this and may report back to Cabinet on the previous strategy

and work programme to align it with Supercharging EV Infrastructure

The significant parts of the existing work programme under the strategy need to be brought in and presented as part of the Supercharging EV Infrastructure Work

Feedback from office

Supercharging EV Infrastructure Work Programme (as the **only** work programme). [This is the feedback that the Minister conveyed directly to EECA when the paper was briefly discussed at the end of the monthly CEs meeting this afternoon]

Many actions in the existing strategy and work programme remain relevant to the government's Supercharging EV Infrastructure work programme and are actively being carried through and worked on. However, some actions do not align and we have been working on the assumption that these would not be carried through. For example, action 2.a.i on research into equity of access to home charging is not currently being progressed by MoT as it does not align with the focus on public charging infrastructure. (For reference, I did an initial skim of actions and think approx 10 would probably carry through in full; 20 may need tweaking, reframing or further consideration, and 3 may be fully discontinued).

I note there was wide engagement with stakeholders on the previous strategy and we continue to get questions about the status of the strategy going forward.

To help us finalise the wording included in the Cab paper, we're keen to understand the Minister's preference for treatment of the previous strategy and communications to stakeholders going forward.

We see the main options being:

 Formally updating/replacing the previous strategy and work programme with the Supercharging EV Infrastructure work programme. We expect this could include closing some actions, rewording or combining actions to align with Supercharging EV Infrastructure priorities. This could be accompanied by comms to stakeholders and/or the wider public. (Note – given the previous strategy was agreed by Cabinet, we've been working under the assumption that formal changes or discontinuation of the strategy would need to be agreed by Cabinet and we would include wording in the current Cabinet paper to reflect this).

• No formal update/replacement of the previous strategy and work programme but it would not be progressed, and work would continue under the Supercharging EV Infrastructure work programme.

The former would be our recommended approach as it provides the greatest clarity to government agencies and sector stakeholders. If agreed, we would look to provide advice to the Minister of Transport and Energy on the detailed Supercharging EV Infrastructure work programme in April/May to update/replace the previous strategy. This advice would include a proposal for the treatment of each action from the previous work programme.

The updated Cab paper is due <u>COP Monday</u> so would appreciate if you could get a response relatively quickly. Happy to chat if you have any questions.



TALKING POINTS – EV CHARGING ROUNDTABLE

Addressing barriers to connect to electricity networks

- Addressing connection costs and timeframes to connect to electricity networks are key priorities for me.
- I also recognise the challenges with differences in practices between councils, and traffic management costs.
- I am following work at the Electricity Authority on regulating connection pricing for electricity distribution businesses (EDBs). As you will be aware, the Electricity Authority has also established a Network Connections Technical Group to assist with changes to the Electricity Industry Participation Code 2010 to improve the efficiency of network connections. I encourage you to continue engaging with these processes.
- I am encouraged by the actions both charge point operators (CPOs) and EDBs are taking to improve processes for connections. It is also good to see Electricity Networks Aotearoa is progressing work with the Electricity Authority and EECA in their Journey Mapping Project and range mapping.

Government co-investment in EV charging infrastructure

- I am progressing changes to the government's co-investment approach so that we can maximise value from public investment in the charging network \$ 9(2)(f)(iv)
- I expect the updated approach to investment will reflect:
 - A focus on recycling and reinvesting government funding. This would move the model away from grants towards concessional loans.
 - A two-stage approach to the procurement with an initial expression of interest stage to gauge market interest, followed by contestable investment rounds (the design of which would be refined based on the response to the first stage).
 - Robust assessment of applications against criteria focused on value-for-money.
 - o A market-led approach in terms of locations and charger types/capacity.
 - Potentially encouraging applications for larger portfolios of chargers to accelerate the rollout and reduce administrative burdens on applicants.

Wider work programme

- Other work is progressing to ensure there is an enabling environment for public EV
 charging. This includes updates to standards to reduce the compliance costs of new
 electrical installations and pursuing amendments to EECA's legislation to enable the
 regulation of smart devices including smart EV chargers.
- Officials will reach out to you shortly to explore the consenting barriers to installing new chargers.

ADDITIONAL CONTEXT

Officials' engagement with CPOs

- The Supercharging EV Infrastructure Taskforce had a scheduled meeting with CPOs on Friday 9 August to discuss the updated co-investment approach at a high-level.

Update on Electricity Networks Aotearoa (ENA)'s work

- Tracey Kai, ENA's Chief Executive, wrote to you on 15 July 2024 with an update on ENA's work, and the enablers and challenges around public EV charging infrastructure.
- Enablers and challenges:
 - EDBs are concerned that the Electricity Authority's work on connection costs will shift upfront costs of connections from CPOs or other connecting customers to wider ongoing users of the network.
 - Some EDBs have also raised the need for mandating smart charging to avoid network impacts of increasing EV ownership.
 - The ENA views that the large load that charge hubs present needs to be managed carefully and that "delays" to connections may be the required time to plan and build new capacity safely.
- Ongoing work by the ENA:
 - The ENA is working with the Electricity Authority on the Future Networks
 Forum Connection Journey Mapping Project which identifies 13 actions for a
 more nationally consistent connection process and improved customer
 experience. Actions include standardising terminology, quote letters,
 applications and terms and conditions; and introducing cost recovery for all
 costs at contractual design stage to help EDBs' resourcing.
 - The ENA is working with the Electricity Authority and EECA to progress work on mapping capacity of chargers. This will help CPOs plan investments in areas where network upgrades are less likely to be required.
 - The ENA has encouraged its members to establish a 'CPO Relations Manager' to improve working relationship with CPOs.

Please find attached OC240788 – Update on Supercharging EV Infrastructure work programme and co-investment (both cover briefing and draft Cabinet paper).

Following the Minister's roundtable session yesterday, we were asked to provide more detail on the engagement on the co-investment model that has taken place this year:

- Taskforce agencies met with charge point operators in late May 2024. The purpose of this meeting was to signal the scope of work on the co-investment model, to share the Minister's objectives for government co-investment, and talk at a high-level about different options for procurement and financing. We welcomed initial reactions during that session. However, recognising they may not want to share their views in that forum, we invited follow up discussions one-on-one, or reflections over email (eg, we had two subsequent conversations with ChargeNet, and one with Z).
- We next met with the full group of CPOs on 9 August 2024. In this session, we provided
 more detail on the high-level direction of the co-investment model. However, we kept the
 content high-level to allow the Minister to go into more detail in his session on 13 August
 2024.
- Between the two sessions, we were limited in what we were able to share with CPOs
 while we provided advice to the Minister and received his feedback on the preferred
 direction. However, we did indicate that CPOs could share their views with officials (eg, we
 have previously received written notes on Drive Electric's preferred framework for
 government investment in charging infrastructure).

- Regarding the Target 9 reporting we have now been able to confirm the right numbers for the Target 9 report with the MfE team so these changes should be being made today.
- Regarding WPQs, OPQs or statements to Parliament I've found just one WPQ that may need correcting (WPQ37711).
 I've also done a quick search of the Hansard and don't believe it has come up in any WPQs, Estimates hearings, or other statements to Parliament.

For question 37711, the correct answer (for chargers as of June 2024) would be: There are currently around 1140 operational chargers in New Zealand.

Hi Dom,

Please find some updated EV charging numbers from EECA, which they have confirmed. A number of changes will need to be made as a result of these updated numbers:

- MoT will action changes to the draft Estimates material for the Minister of Transport.
- The Government's reporting against its targets, specifically Target 9, will need to be changed. I understand the Prime Minister is wanting to publish this report this week. We advise the report should be updated before it is published. We have been unable to get in contact with MFE so far to make this change, and the Office may want to contact PMO about getting this changed. Recommendation from EECA is to use the July figure highlighted below.
- As discussed last week the Office will need to check whether the Minister has responded to any WPQs, OPQs, or made statements to Parliament with the incorrect numbers – if so the Minister may need to correct his previous responses/statements.
