Kia ora koutou

Cabinet yesterday made decisions on how the RIA requirements will apply to 100 Day Plan proposals.

If your agency has a Cabinet paper getting lodged imminently for consideration by Cabinet on Monday please get in touch with us ASAP and we can provide new wording for the impact analysis section (if it is not too late already).

- For proposals involving the repeal of legislation (and not seeking approval for new policy), no RIS is required
- For new proposals:
 - o RISs will be required, but formal quality assurance is not needed (at the very least we recommend peer review of RISs, and for the authors to note any limitations and constraints).
 - o If agencies do not have time to prepare comprehensive impact analysis, they can focus on cost benefit analysis and implementation issues.
 - Post-implementation assessments will be required, one year after enactment of the relevant legislation.

In some cases, your agencies will have already started preparing RISs for repeal proposals. Sorry we haven't been able to provide clarity before this point on whether or not those RISs were required. If you have a completed RIS ready to go we recommend they're still submitted that to Cabinet, but as the preparation of RISs in that situation is not required we'll leave the ultimate decision on whether to submit it to Cabinet up to you and your Minister.

We will be urgently revising our 100 Day Plan guidance and providing that as soon as possible.



Kia ora Gayelene,

I have an update to share on the RIA requirements for 100 Day Action Plan proposals. It looks like Cabinet has suspended the requirement for RISs for 100 day proposals which repeal legislation, although we have not yet seen the final version of the Cabinet paper or minute.

Although we recommend you still provide the RIS you prepared to Cabinet, whether or not you do that it is a decision for you and your Minister. Therefore we've provided two versions of the impact analysis wording depending on whether or not you want to provide the RIS:

The Climate Implications of Policy Assessment (CIPA) team has been consulted and confirms that the CIPA requirements apply to this proposal. The discontinuation of the clean car discount is expected to result in a total cumulative increase in emissions of approximately 1,100 to 2,200 Kt CO2-e, by 2050. Eliminating rebates for low emissions vehicles and fees for high emission vehicles is expected to elevate emissions due to a potential decrease in the adoption of low emissions, resulting in higher uptake of higher emissions vehicles. The CIPA team has reviewed the results and considers them reasonable for indicating the impact of this change.

The discontinuation of the clean car discount is expected to result in a total cumulative increase in emissions of approximately 1,100 to 2,200 Kt CO2-e by 2050. Eliminating incentives for battery electric vehicles (BEVs) is expected to elevate emissions due to a potential decrease in the adoption of BEVs, resulting in higher prevalence of traditional, emissions producing vehicles. The CIPA team has reviewed the results and considers them reasonable for indicating the impact of this change, given the high level of uncertainty.

Please see below a summary of the documents proposed for proactive release with respect to ending the Clean Car Discount

Attached are the mark up versions for docs where we are proposing to withhold information, and redacted versions applying redactions and watermarks for all docs.

We would appreciate a response from the Office as soon as possible, and if we are able to proceed with the proactive release either today (or early next week) that would be helpful in responding to the many OIA requests we have received for this information. Currently we have 14 OIA requests (including 2 OIAs to the Minister). Provided we can do a proactive release by early next week, about 9 of these could be responded to before the Christmas break (by refusing the request under 18(d) and providing a link to the proactive release). The remainders could be refused in part next year (once the additional information that has not been proactively released is collated, analysed, and consulted on – this includes the 2 OIAs to the Minister). Additionally, I note, proactively releasing this information is also expected to reduce the of further requests we or the Minister may otherwise receive.


