

## Output Plan deliverables achieved 2024/25



The Output Plan provides clarity on what is expected of the Ministry throughout the year. Our Output Plan deliverables for 2024/25 include the deliverables agreed with the Minister or Associate Minister of Transport (based on their portfolio responsibilities) during the financial year.

Regular reviews of the Output Plan enable the Ministry to reallocate resources, particularly if new priorities emerge during the year. Any changes to the Output Plan must be agreed by the Minister or Associate Minister of Transport.

We report on level of delivery against the Output Plan as a performance measure in our Annual Report. The table below shows the Ministry's deliverables achieved for 2024/25<sup>1</sup> and is published as a supplementary document to the Annual Report.
